# HFHS Advantage Tiered Access EPA Plan for Henry Ford Health System Employer Group

The Henry Ford Health System employer group offers its employees the HFHS Advantage Tiered Access product and Consumer Driven Health plan options.

The tiered access has two in-network tiers. Member cost sharing amounts vary based on the provider tier where the member seeks care. There are separate tier 1 and tier 2 deductibles and coinsurance.

- Tier 1 consists of a narrow network and lower out of pocket costs.
- Tier 2 has a broader network with higher out of pocket costs.

# Note: Members can go to providers or facilities in each tier. Their cost share is determined by the provider or facility used.
