<b>Asthma: AMR, PQI05 &amp; PQI15</b>	Members between the ages of 5 – 64 years with asthma who fill their long-acting controller medications	Members must fill their <u>long-acting</u> asthma controller medications throughout the year and complete the online attestation	\$25 (eligible up to 4x's annually)	AAA (PQI measures only), Performance Withhold, Health Equity, Consumer Guide
<b>Prenatal Health: PPC1</b>	All pregnant members	Members must complete a prenatal visit in the first trimester or within 42 days of enrollment as well as complete the attestation, <i>or</i> , provide medical record from provider for 1 <sup>st</sup> trimester visit (small <i>n</i> )	\$100 gift card	AAA, Performance Withhold, Health Equity, PIP, Consumer Guide, Dental
<b>Postpartum Health: PPC2</b>	All members who deliver a live birth	Members must complete a postpartum visit with Care Connections or Ouma which includes a postpartum depression screening between 7-84 days after delivery	\$50 gift card	AAA, Performance Withhold, Health Equity, Consumer Guide
<b>Sexually Transmitted Infection (STI) Screening in Pregnancy</b>	All pregnant members in their 7 <sup>th</sup> or 8 <sup>th</sup> month of pregnancy	Members must request and complete an in-home STI kit from LetsGetChecked (available by calling 833-700-0920)	\$75 gift card	Withhold

<b>Infant Health: LSC</b>	Members age <12 months and <24 months	Members must complete a blood lead screening <u>and</u> complete the attestation, prior to the member's 1 <sup>st</sup> and/or 2 <sup>nd</sup> birthdays	\$25 gift card	Performance Withhold, Health Equity, Consumer Guide
<b>1<sup>st</sup> Year of Life: W30 (W15 denominator)</b>	Members ages ≤15months	Members must complete 6 visits in the first 15 months <u>and</u> complete the attestation	\$100 gift card	AAA, Performance Withhold, Health Equity, Consumer Guide
<b>2<sup>nd</sup> Year of Life: CIS</b>	Members age ≤24 Months	Members must complete the Combo 3 immunizations prior to / by the member's 2 <sup>nd</sup> birthday <u>and</u> complete the attestation	\$100 gift card	Performance Withhold, Health Equity, Consumer Guide
<b>Child &amp; Teen Health: WCV</b>	Members ages 3-21	Members must complete a Well Child Visit (WCV) within the MY <u>and</u> complete the attestation	\$50 gift card	AAA, Consumer Guide
<b>Women's Health: CCS, CHL, BCS</b>	Female members aged 50-74 years: BCS Female members ages 16-24: CHL (within targeted groups) Female members ages 21-64: CCS	Members must complete <i>each</i> measure for which they are eligible <u>and</u> complete the attestation	\$50 gift card for BCS and / or CCS (each) \$25 for CHL	AAA (all 3 measures), Consumer Guide (all 3 measures), Health Equity (CHL)

<b>Diabetic Health: EED</b>	Diabetic members ages 18-75	Members must complete a diabetic eye exam (including the retina) <u>and</u> complete the attestation	\$50 gift card	AAA, Performance Withhold, Health Equity, Consumer Guide
<b>Diabetic Health: KED</b>	Diabetic members ages 18-75	Members must complete a blood draw for an eGFR and a urine collection for an uACR <u>and</u> complete the attestation	\$50 gift card	AAA, Performance Withhold, Health Equity
<b>Dental Health</b>	Members ages 21+ (or 19+ and on Healthy MI Plan)	Members must complete a dental visit (preventive or diagnostic) and complete the attestation	\$50 gift card / \$75 gift card (if the member is pregnant and/or diabetic at the time of dental visit)	Withhold

**Incentive Process:** Member attestation of services will be available on the Molina Healthcare of Michigan website. Members must meet the following criteria to be eligible for incentives:

- Continuous enrollment
- Services rendered within the MY or appropriate look-back period for the MY (e.g., W15 visits from birth to 15 months of age will likely span multiple MY)
- Service must result in a numerator hit, e.g., remove the member from the Missing Services list


Gift cards will not be sent to members until a claim is received for the service, which could be as long as 60-90 days after the service has been completed, based on claims lag.
